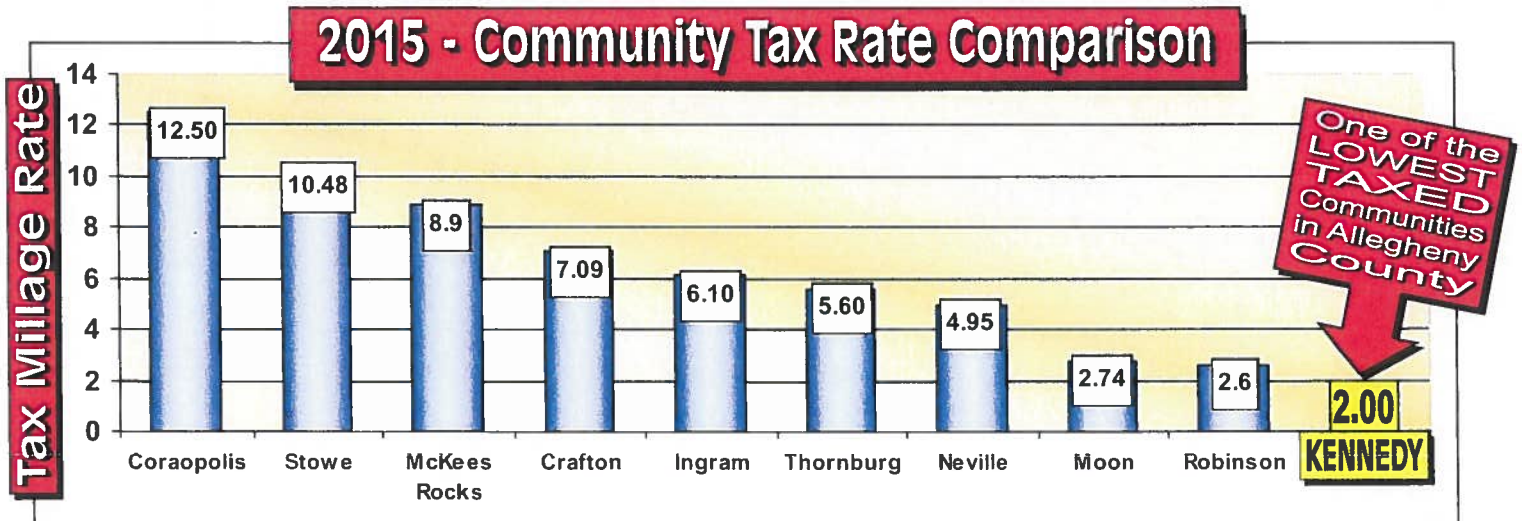


Dear Fellow Taxpayer:

March '15

Enclosed please find your **2015 Kennedy Township Real Estate Tax Bill** proving once again, that your government can *'be effectively managed.'* At the December 2014 Board of Commissioners meeting, Commissioners DiNardo, DePascale, Kulik, Galiyas and Chairman Mollica again adopted your new budget and then set the **TAX MILLAGE RATE of 2.00 MILLS.** The recent county-wide reassessment, general state of the economy in our country, sky-rocketing health care costs, increased utility costs, fuel costs, workers' compensation, the public safety (Police) contract and general liability insurance costs - **PLUS** the cost to help the **Kennedy Volunteer Fire Dept purchase a new fire truck** to keep our residents safe, have all substantially increased **again** for 2015 but yet, we were able to continue the *proven and efficient management of our Township!*

We have worked diligently to consistently keep your Township Taxes as low as possible for all residents. We are once again exceptionally pleased to have the low tax millage rate of 2.00 mills which is extremely affordable for all the professional services provided. With this remarkably low tax rate, Kennedy Township is once again proud to be one of the **LOWEST TAXED COMMUNITIES IN ALLEGHENY COUNTY** and has the **LOWEST TAX MILLAGE RATE OF TEN (10) SURROUNDING COMMUNITIES** as shown:



Basically, what this means to you as a taxpayer is that if your house had a fair market value of \$100,000.00 and you lived in **Coraopolis**, your local municipal taxes would be **\$1250.00**; if you lived in **Stowe**, your taxes would be **\$1048.00**; in **Moon**, taxes would be **\$274.00**; in **Robinson** taxes would be **\$260.00** but in **KENNEDY TOWNSHIP**, that same house would **cost you only \$196.00** in township municipal taxes at discount!

Reflected in your 2015 Township Tax Bill is a tremendous amount of hard work and dedicated effort in continuing to maintain the financial strength and stability of Kennedy Township. We are extremely proud of our many accomplishments and will continue to bring **'First Class Services'** to all residents at the lowest possible cost.

# There are three (3) convenient ways to pay your 2015 Kennedy Township Taxes

**1 BY MAIL**

Include a Self-Addressed Stamped Envelope for a Validated Receipt

**2 IN PERSON**

Tax Office Hours

**3 DROP-OFF BOXES**

Police Station - 16/7 or Tax Office during Normal business hours

## ATTN: SENIOR CITIZENS - SPECIAL TAX RELIEF PROGRAM

In addition to the low tax millage rate, the Board of Commissioners has also provided a special tax discount program especially for Senior Citizens residing in Kennedy Township. This program which has been in effect for the past ten (10) years, allows all qualifying Seniors to receive a 10% **DISCOUNT OFF** their Kennedy Township Tax Bill. To qualify, there are only three mandatory requirements which an applicant must meet:

1. If single, the applicant must be age 60 or older during the year 2015. If married, either spouse must be age 60 or older during the year 2015. If widowed, must be age 50 or older.
2. The applicant must have owned one or more primary residences in Allegheny County continually for at least the past **ten (10) years**.
3. Total household income cannot exceed \$30,000.00 for the previous year (*for calculating total income, use only 50% of Social Security Benefits, SSI and Railroad Retirement Tier 1 Benefits, except Medicare Benefits*).

**PLEASE NOTE** IF YOU HAVE BEEN APPROVED AND ARE RECEIVING THIS TAX RELIEF ALREADY, YOUR TAX STATEMENT WILL REFLECT THE 10% DISCOUNT AND **YOU DO NOT HAVE TO RE-APPLY.**
