We would ask for your cooperation in not parking on the street during construction. If you must park on the street, please have your vehicle removed prior to the start of work or if you do not park on the street, make sure to be readily available to move your car as we are working on other streets and may not get to your street first thing in the morning. Cars that are parked on the street during construction without having someone available to move them during the hours noted above, may be towed at the owner's expense.

We would also ask that during construction that you keep your travels in and out of the road being milled or paved to a minimum. If you must travel during this time, we urge you to exercise **EXTREME CAUTION** throughout the construction area.
